## <u>Article I</u>

<u>Sec. 2</u> Membership entitles two (2) members of the same family, living in the same household, to all privileges of the Society including the right to vote at all General and Annual Meetings and to run for any office of the Society. Membership entitles the holders to receive all bulletins issued by the Society based on one issue per household

Membership fees are due and payable on the first day of each fiscal year **[Sept. 1]** and one full year's fee is payable regardless of date of application, except that after March 1, one half of the fee will be payable, in accordance with Bylaw Article IV.

<u>Sec.4</u> Institutions and Organizations shall be eligible for membership in the Society upon the same conditions as persons, however they are denied a vote. No commercial organizations shall be eligible for membership.

<u>Sec. 5</u> Membership renewed in the month it expires **or the following month** shall be deemed to be continual membership. Any member failing to renew as stated above shall have the membership suspended, and thereafter be entitled to no membership privileges or power in the Society. Any suspended member may apply to rejoin the Society...

<u>Sec. 6</u> Any member for private commercial gain must not use the Society name.

## <u>Article VI</u>

<u>Sec. 1</u> Any member who has not withdrawn from membership nor been suspended nor expelled as herein provided shall have the right to vote at any meeting of the Society. Such votes must be made by the individual member and not by proxy or otherwise.
