Vendor Information

Vendor passes - wristbands, are required for entry to the Show including Friday set-up.

Passes will be issued when entering at the venue on Friday, May 30, 12:00 pm. If you have extra help to unload, set up, and packing and loading, please give their names to the volunteers at the door. They do not need a pass, but if you want them to have regular access to the show, they can buy a ticket when they arrive the day(s) of the show. Admission is \$10.00 per day.

2 passes per vendor and good for the duration of the show. 'PASSES' WILL NOT BE MAILED OUT.

Parking is free for vendors and the public. There is NOT any overnight parking or camping allowed at this property.

There will be overnight security. Beverages and light snacks will be available for purchase.

SET-UP and MOVE OUT

Friday, May 30 Noon - 7PM Set Up Only

There will be volunteers directing the vendor traffic to unload closer to the building.

Our volunteers will ensure your spaces are ready by Friday, May 30, 12:00 pm. Please show patience and grace with all our volunteers and vendors.

We will have security overnight, but as a rule, don't leave anything valuable or easy to steal.

A great time to come put the final touches on your set up.

GENERAL RULES

1. Merchandise must be of excellent quality and in keeping with the tradition of the show: **Antiques, collectibles, and nostalgia items.**
2. Items shall be priced, and reproductions or distressed/ repaired items clearly labeled.
3. Fire regulations and crowd movement require that all merchandise and/or tables, will be confined to the limits of the rented space. No items under table if access to aisle.
4. Neither the WRAC nor the City of Edmonton will be held responsible for damage or theft or whenever caused. Vendors may wish to carry insurance for such an event.
5. Consumption of intoxicants within the sales area is forbidden. Violators will be expelled.
6. No pets are allowed in the venue, except as required as aids or guide dogs.
7. Applications received unsigned or without payment will be returned unprocessed.
8. Information about the club, will be displayed at Club member table.
9. Vendors must always have a person at their space and not cover tables, etc in space during show hours.
10. The Show Chair reserves the right to refuse any application without giving a reason and is the final arbiter of all matters pertaining to this Show.
